a) Cal Expo Update

California State Fair and Food Festival is the campaign for 2019.

State Fair Taco is coming back. There will be a new Chinese food vendor along with a Vegan food booth.

Esports will be in Building 5 as a gaming facility.

Fireworks on Fridays and Saturday will be a Drone show on Friday, Saturday and Sunday nights.

New Acting Police Chief would like to expand the walk along program.

Currently have two soccer games on the field during State Fair.

b) Community Stage

Erica Kendall explained the process of getting on the Community Stage. She passed out the handbook and explained how the online application works. Deadline to apply is April 15, 2019.

c) Cultural Advisory Council Kitchen Program

Michelle Johnson, CA Kitchen coordinator reported that the California Kitchen program is a celebration of the food and cooking of California. This year the kitchen received a specialty crop block grant from the Department of Food and Agricultural high lighting cherries, honey, peaches, pears and olive oil.

There is a classroom program that includes tasting classes for wine, beer, olive oil, honey and cheese. These paid classes and take place on Friday, Saturday and Sunday.

The Cooking Theater is a series of Chef Challenges and Cooking Demonstrations. The Cultural Advisory Council in the past has done 3 teams of 2 and used a mystery ingredient. The cooking day for CAC is Saturday, July 27, 2019, at 11am-2-pm.

 - Courtney Tyler of CT Events reported that the gala is June 27, 2019. Best of California begins at 5:30pm with the dinner at 7:00pm.
